DIRECTIONS FOR USE

Enviroplex® can be applied to most vegetables, cucurbits, field crops, row crops, deciduous fruit and nut trees, grapes, berries, olives and citrus. Timing and rate of application for each crop is critical for best results.

Mixing with irrigation water for field storage is generally not recommended. Products blended with irrigation water should be used immediately and not stored for prolonged periods.

FOLIAR APPLICATION RATES

VEGETABLE, CUCURBIT, FIELD AND ROW CROPS: Apply 2 to 4 quarts per acre. In aerial application use a minimum of 5 gallons of water per acre. In conventional sprayers use a minimum of 15 gallons of water per acre. May be applied through center pivot irrigation systems.

DECIDUOUS FRUIT AND NUT TREES, GRAPES, OLIVES AND CITRUS: Apply 2 to 6 quarts per acre. In aerial applications use a minimum of 5 gallons of water per acre. In dilute or concentrate sprays use a minimum of 15 gallons of water per acre.

FERTIGATION APPLICATION RATES

APPLICATION THROUGH DRIP IRRIGATION - Inject after irrigation filter.

TRANSPLANT WATER, ALL CROPS: Apply 1 to 5 gallons per acre in a minimum of 100 gallons solution.

NURSERIES: Apply 1/2 to 4 quarts per 1000 sq. feet through drip or sprinkler irrigation systems.

NOTE: For best results use the lowest possible volume for thorough coverage and a small droplet size. Repeat applications may be beneficial.

GENERAL INFORMATION

Enviroplex® contains nitrogen, phosphate, potassium, zinc, copper, iron, manganese and boron. Enviroplex® is non-phytotoxic when used as directed. Enviroplex® is recommended for foliar application as a dilute spray solution and should be applied early in the crop's growth cycle.

Enviroplex® will be influenced by various soil and environmental conditions and should be applied under conditions of optimum plant growth. Optimum conditions are defined as adequate humidity, moderate temperatures and adequate soil moisture.

CAUTION: Always check for compatibility with other products prior to use. Do not mix with conventional calcium based fertilizers. Enviroplex® is not compatible with conventional products containing the salts of heavy metals.

CAUTION: Foliar application of Enviroplex® close to harvest may leave a brown residue on the harvestable portion of the crop. Rainfall, sprinkler irrigation or high humidity should alleviate this condition.
